## Application to Become a Member

I understand Organization is a private membership faith-based organization formed under the Bill of Rights in the U.S. Constitution and the 1982 Canadian Charter of Rights and Freedoms and all amendments and federal laws which support and guarantee these privileges of personal freedom in the USA and Canada. I also understand Organization is in full compliance with the US Code 508(c)(1)(a) as a nonprofit, nontaxable private membership faith-based organization; and Section 2 of the 1982 Canadian Charter of Rights and Freedoms as a Peaceful Assembly Association.

2. BENEFITS. I understand I am entitled to all of the benefits of Membership in Organization including the privilege to include my family, dependents and pets in my membership. These benefits include Freedom of: Choice, Confidentiality, Non-Discrimination, Peaceful Assembly, Privacy, Self Determination, Self-Expression, Speech, and legal protection of all Civil Rights guaranteed by the U.S. Constitution when in the USA and the 1982 Canadian Charter of Rights and Freedoms when in Canada, as well as research and training opportunities.

### CONSTITUTIONAL FREEDOMS AS A UNITED STATES CITIZEN OR CANADIAN CITIZEN

1. I understand Organization is a private health education association formed under the First, Fourth, Fifth, Ninth, Tenth and Fourteenth Amendments to the U.S. Constitution and Section Two of the Canadian Charter of Rights and Freedoms to grant me, my dependents and pets all the rights and protections set forth therein anywhere in either the United States or Canada.

2. I understand and assert my right to freedom of expression both spoken and written and the right to freedom of assembly guaranteed to me, my family and my dependents under the First Amendment to the United States Constitution.

3. I understand and assert my right to privacy and the inalienable human right of self-determination, and all of the other freedoms guaranteed to me, my family and dependents under the Fourth and Ninth Amendments to the United States Constitution.

4. I understand and assert my right for myself, my family, dependents and our pets to all of the freedoms and rights not specifically granted to the federal government nor prohibited to the state governments by the Constitution as stipulated in the Tenth Amendment to the United States Constitution.

5. I understand and assert all of my civil rights, including due process and equal protection under the law, guaranteed by the Fifth and Fourteenth Amendments to the United States Constitution which guarantees these rights to me, my family and my dependents.

6. I understand and assert my right against self-incrimination for the opinions voiced in any media by myself, my family and my dependents as guaranteed in the First and Fifth Amendments to the United States Constitution on the basis that our opinions are protected under the Bill of Rights and may change from time to time.

7. I understand it is my responsibility to maintain the confidentiality of all communications between me and other Association members. I also understand it is my responsibility to maintain the confidentiality of all communications of an Association member I hear or inadvertently overhear at any time. I further understand that anything I say or write is communicated under the umbrella of Organization and is, and will be held absolutely confidential.

I acknowledge and understand Organization uses only professional members who are trained, certified and/or licensed to competently coach, demonstrate, educate, empower, facilitate, instruct, mentor, supervise, teach, train and tutor me using all of the coaching techniques and tools of Organization.

9. I understand I am responsible for the results my decisions have on me, my family, dependents and pets; and I hold Organization and all members of Organization harmless for all harm I may cause myself or others because of my decisions. I also understand Organization does not carry malpractice insurance because all members of Organization take full responsibility for any harm that may be caused to them, their family, dependents and pets as a result of their own decisions.

I understand Organization is giving me a copy of this Membership Application for my permanent file so I can refer to it in preparing for my and my family's and dependents education and training sessions. I do this to learn more about improving and managing my own health, nutrition, therapies and wellness and that of my family, dependents and pets.

11. I declare that I have read and understand this application and am qualified to make this decision to join this Organization to experience the services offered and learn how to improve and manage my own health, nutrition, therapies and wellness, and that of my family, dependents and pets.
